CONTRACT AGREEMENT

THIS AGREEMENT, made this 10th day of March, 2023 between THE PROVINCIAL GOVERNMENT OF DAVAO DEL SUR with address at Capitol, Barangay Matti, Digos City, Davao del Sur (hereinafter called the "Entity") and YUSRA CONSTRUCTION SERVICES with address at Purok 1 Zone 6 Captain E.  - v. Supplemental or Bid Bulletins, if any;
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of NINETY NINE THOUSAND PESOS (P99,000.00) or such other sums as may be ascertained, YUSRA CONSTRUCTION SERVICES agree to CONSTRUCTION OF 1 UNIT HANDWASHING STATION located at TACUL AGRICULTURAL TECHNOLOGY HIGH SCHOOL ANNEX, MAGSAYSAY, DAVAO DEL SUR in accordance with his/her/its Bid.
- The PROVINCIAL GOVERNMENT OF DAVAO DEL SUR agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
