

THIS AGREEMENT, made this 8th day of March, 2022 between **THE PROVINCIAL GOVERNMENT OF DAVAO DEL SUR** with address at Capitol, Barangay Matti, Digos City, Davao del Sur (hereinafter called the "Entity") and **MAGNUM BUILDERS CORPORATION** with address at Barangay Magugpo North, Tagum City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONCRETING OF BARANGAY HALL GROUNDS located at POBLACION DOS, BANSALAN, DAVAO DEL SUR** under **IB No. C-019-22** (hereinafter called "the Works") and the Entity has accepted the Bid for **FOUR HUNDRED NINETY-SEVEN THOUSAND PESOS (P497,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
