NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of TWO MILLION FOUR HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED EIGHT PESOS AND 31/100 (P2,497,608.31) or such other sums as may be ascertained, EDSAL CONST. AND SUPPLY INC. agree to CONSTRUCTION OF POTABLE WATER SYSTEM BRGY. MAHAYAHAY, HAGONOY, DAVAO DEL SUR in accordance with his/her/its Bid.
- 4. The PROVINCIAL GOVERNMENT OF DAVAO DEL SUR agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
