



WEEKLY ACCOMPLISHMENT REPORT

(Period Covered: December 27, 2021 – January 2, 2022)

Campaign Against Illegal Drugs - 1

Recovery of Illegal Drugs (Dried Marijuana Leaves)



On December 30, 2021 at about 4:55 PM, PNP personnel of Kiblawan MPS led by **PLT NEIL T JAMILA** under direct supervision of **PCPT IAN MARC S POLESTICO**, ACOP together with 2nd DSPMFC led by **PLT JOSEPH ORBELL S POJAS** under the supervision of **PLTCOL REY O SANTILLAN**, FC, DSPMFC conducted prophylactic and preventive patrol at Sitio Sixten, Brgy. Kimlawis, Davao del Sur to pre-empt unlawful activities perpetrated by B'laan Bandits.

That while the said operating troops on foot patrol returning to Kimlawis PNP Sub-Station 1, they spotted two (2) unidentified suspicious male persons more or less 20 meters from their position particularly at Sitio Aglomay, Brgy. Kimlawis, Davao del Sur. Upon approaching for verification, the aforesaid male persons suddenly ran and fled toward the vegetated area of Sitio Bantong also on same locality leaving behind their baggage that contained dried marijuana leaves including stalks and branches with estimated weight of 100 grams with estimated DDB value of Twelve Thousand Pesos (Php 12,000.00).

Further, said PNP personnel immediately conducted pursuit operation but yield negative result due to rough and highly vegetated terrain. Team arrived Kiblawan MPS at about 6:55 PM of same date with no untoward incident happened.

The recovered dried marijuana leaves are now under the custody of said station for proper documentation and to be turn-over to Provincial Crime Laboratory, Digos City for quantitative and qualitative examinations. Intel operatives are now conducting lateral coordination with the B'laan Elders and utilizing BINs in the area for identification of the suspects.

Campaign Against Illegal Gambling - 3



On December 27, 2021 at about 5:30 P.M. PNP personnel of Kiblawan MPS led by PSSg Wyndell Jay C Cejas, Intelligence PNCO under the direct supervision of PCPT IAN MARC S POLISTICO, ACOP, together with the personnel of RSOG 11 led by PLT WELQUIN T ENCISO and PLT LOUIE P BALMORI, under the direct supervision of PLTCOL RONALD LIM LAO, C,RSOG11 conducted a joint anti-illegal gambling operation at Prk. 4, Brgy. Panaglib, Kiblawan, Davao del Sur which resulted in the arrest of **Roselda Lebrando Banuelos**, 35 years old, female, businesswoman and a resident of the aforesaid place. The suspect was caught in the act soliciting bet money from the police officer who acted as poseur bettor who was betting the number 04 using marked money of one (1) pc Twenty-peso bill bearing serial number BX221194.

Confiscated from the possession and control of the arrested person were the following:

- a. One pc cut-out paper improvised "kotejo" as bet receipt with bet number;
- b. One pc color black ball pen;
- c. One pad tally sheet with written bet numbers; and
- d. One (1) pc Twenty Pesos bearing serial number BX221194

The apprehended suspect and the recovered pieces of evidence were in the custody of Kiblawan MPS for proper disposition and a pertinent document are being prepared for filing of appropriate charges against the suspect.

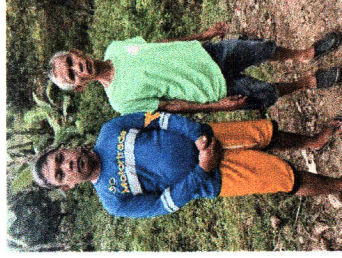


On December 30, 2021 at about 1:30 PM, Padada MPS led by **PLT RONALD DAHAB DITAN** – DCOP under the direct supervision of **PCPT CHRISTIAN C LUDGATE** – OIC and Intel personnel of 1104th MC RMFB 11 led by Pat Ian Jake Ruiz under the supervision of **PCPT RICHARD P LAPACEROS** – OIC conducted joint Anti-illegal gambling operation particularly **COCKFIGHTING** at Purok 4, Brgy. Palili, Padada Davao del Sur (boundary of Palili-Padada and Palili-Sulop, Davao del Sur) that resulted to the arrest of two (2) suspects namely: **MARVIN RABUYA ABREGANA**, 41 years old, male, single and a resident of Purok 2, Brgy Northern Paligue, Padada, Davao del Sur; and **EDUARDO DELGADO PERANTE**, 74 years old, male, married and a resident of Purok 1, Brgy Lower Limonzo, Padada, Davao del Sur. Subject persons were caught in act while conducting illegal cockfighting in plain view located at the vacant lot near the house of Ptolemy Lanticse - former Brgy Chairman of Brgy Palili-Padada, Davao del Sur. That other suspects fled to different directions after seeing the operating team.

Recovered from the possession and control of aforesaid suspects were the following pieces of evidence:

- a. One (1) pc wounded live rooster with cockfighting gaff attached;
- b. Four (4) pcs dead roosters; and
- c. Two (2) pcs One Hundred Peso bill amounting to Two Hundred Pesos (Php 200.00) as Gambling bet money.

Further, hot pursuit operation is being conducted for possible apprehension of other suspects. The arrested suspects and the confiscated/recovered pieces of evidence were brought to said station for proper disposition.



On January 2, 2022 at about 3:43 PM, personnel of INTEL, CDEU personnel led by **PLT DIOSDADO S NIONES II** together with 1st DSPMFC led by **PLT JUNE**

MAR D. PASOBILLO under the direct control and supervision of **PLTCOL HAMLET M LERIOS**, OIC, conducted joint anti-illegal gambling operation (hantak) at Pangaguran, Soong, Digos City that resulted in the arrest of the following suspects:

- a. **Rolando Alacida Tongcos**, 53 years old, farmer a resident of Purok Mahogany, Soong, Digos, City;
- b. **Arjay Wabe Tongcos**, 28 years old, male, jobless, and a resident of Sitio Mahogany, Brgy Soong, Digos City; and


The aforementioned suspects were caught in the act of engaging an illegal gambling activity (hantak) at above stated place. Recovered from their possession and control were the following:

- a. One cary y cruz rock (antogon)
- b. Two pcs coins (antogon)
- c. Bet money amounting to Php 360 pesos in different denomination;

Subsequently, the aforementioned suspects were now in custody of Digos CPS while preparing documents for inquest proceeding;





Other Significant Activities

After Activity Report re Mock Election conducted at Digos City and Sulop Municipality

On December 29, 2021, the COMELEC conducted Mock Elections in Digos City and Sulop Municipality, Davao del Sur to test and ensure adequate security, accuracy, system and functional capability and integrity of Vote Counting Machines (VCMs); Transmission Devices; and Consolidation and Canvassing System (CCS) as well as to simulate the procedures relative to the conduct of election from deployment to voting, to consolidation and transmission of results, to further develop public confidence and acceptance of the Automated Election System (AES) and to validate the effectiveness of the planned health and safety protocol to be implemented against COVID – 19 for the May 9, 2022 NLE.

The said activity was supervised by ATTY AIMEE P FEROLINO, COMELEC Commissioner and participated by Mr. Abraham E. Ibang, Election Assistant II with the supervision by ATTY. JENNIFER P ANCLA, Provincial Election Supervisor, ATTY. FAIZAH K TEJERO, City Comelec Officer IV and other members of the COMELEC.

Digos CPS and Sulop MPS had conducted security and deployment of troops on the said activity as shown below.

a. Deployment of Troops



On December 29, 2021 at about 6:00 AM, **PLTCOL HAMLET M LERIOS, OIC** Digos CPS and **PCPT DARRYL FRANCIS N RAMOS, OIC** Sulop MPS conducted briefing regarding mock election 2022 and deployment of troops in order to ensure safety and preempt any hostile plan of lawless elements.

b. Casting of Votes



On December 29, 2021 at about 7:00 AM, **PLTCOL HAMLET M LERIOS, OIC** Digos CPS and **PCPT DARRYL FRANCIS N RAMOS, OIC** Sulop MPS personally oversee the ongoing Mock Elections at Damias Elementary School Brgy. Goma, Ramon Magsaysay Elementary School, Brgy. Zone 3, Digos City, Sulop Central Elementary School and Talas Elementary School.

c. Counting and Transmission of Results



On December 29, 2021 at about 10:30 AM, Atty. Kaye Enumerable, Asst. Regional Election Director together with Atty. Jennifer Ancla, Provincial COMELEC of Davao Del Sur arrived at the polling places to evaluate and assess the ongoing counting and transmission results of Mock Elections.



On December 29, 2021 at about 10:45 AM, the undersigned conducted inspection at Damias Elementary School Brgy. Goma, Ramon Magsaysay Elementary School, Brgy. Zone 3, Digos City, Sulop Central Elementary School and Talas Elementary School to ensure that the implementation of policies was consistent with the IATF guidelines and security personnel were reminded to maintain alertness and to be vigilant at all times.

d. Canvassing



On December 29, 2021 at about 12:00 NN, voting is officially closed at all polling places and canvassing started after which was the transmission of results. The COMELEC had only compiled the 82% votes cast at around 12:00 noon and successfully transmitted the number of votes. After the transmittal of votes, Vote Counting Machines used were transported to the SP BUILDING while canvassing is being prepared.

All units of this office conducted daily checkpoint operations covering the period of December 27, 2021 – January 2, 2021 which resulted in the apprehension of **Three Hundred Twenty-two (322)** traffic violators. As shown on the matrix.
