## **WEEKLY ACCOMPLISHMENT REPORT**

(Period Covered: December 6-12, 2021)

### **Campaign Against Illegal Drugs**

#### **Eradication of Marijuana**



On December 10, 2021 at about 6:00 AM, personnel of PNP DEG SOU 11 (Lead Unit) led by **PLT NEIL EDWARD RETANA** under the supervision of **PMAJ SHERYL Y BAUTISTA**, Deputy Chief together with personnel of Kiblawan MPS led by **PCPT IAN MARC S POLESTICO**, ACOP together with 39IB Philippine Army-Delta Company led by **PFC IVAN M GAMAYON**, 2nd DSPMFC led by **PLT JAMES RAFNIEL S RAGO**, Intel PCO, under direct supervision of **PLTCOL REY O SANTILLAN**, FC, personnel from PDEU under the supervision of **PMAJ EDILBERTO CABILLO**, personnel of PIU, DSPPO under supervision of **PLTCOL RAMIL M MACARAMPAT**, RMFB 1104<sup>th</sup> led by Pat Ian Jake Ruiz-Intel operative under direct supervision of **PCPT RICHARD P LAPACEROS**, OIC and personnel from Davao del Sur CIDG led by **PLTCOL DEMETRIUS E TAYPIN**, Provincial Officer conducted Marijuana Eradication under COPLAN "ROLLO" with PDEA Coordination No. 30004-122021-0121 in the mountainous area of Sitio Lamlango, Brgy. Bulol-salo, Kiblawan, Davao del Sur which resulted in the eradication of Eleven Thousand Five Hundred Hills (11,500) of Fully-grown Marijuana Plants (FGMJP) with an estimated SDP Value of PHP 2,400,000.00 eradicated from site with Grid Coordinates of 51NYH 36959 13864 and a total land area of more or less 15,000 SQM. The Said operation was instigated by a report from a reliable informant that a marijuana plantation is being cultivated therein however, suspect/cultivator yet to be identified.

At about 12:00 NN of same date, abovementioned personnel returned to Kiblawan MPS and the Ceremonial Burning of the One Hundred Hills of FGMJP was done in Kiblawan Municipality witnessed by Kagawad George C. Laurente and Kagawad Roderick S. Zamora both are Elected officials of Brgy. Poblacion, Kiblawan, while the Five hills of FGMJP were in the possession and control of PDEG subject for Qualitative and Quantitative Examination.

## Buy-Bust Operations



On December 10, 2021 at about 2:59 PM, PNP , PNP personnel from City Drug Enforcement Unit (CDEU) and Intelligence Unit of Digos City Police Station led by **PLT DIOSDADO S NIONES II**, CDEU/Intel Officer together with the personnel from RIU, PIT, PHPT, PDEU,PIU and PDEA Davao del Sur under the over-all supervision of **PLTCOL HAMLET M LERIOS**, Officer-In-Charge, Digos City Police Station conducted a joint Anti-illegal Drug “Buy-bust” operation with PDEA RO XI Pre Operation Number **30004-122021-0150** at Purok Lapu-lapu, Brgy Dawis, Digos City which resulted in the arrest of **KIRBY ALCOVER ROSALES alias LODS, (Regional Target Top 5 categorized as High Value Individual)** male, 21 years old, single, unemployed and presently residing at Purok Golden Duranta, First Crumb St., Brgy. Zone 1, Digos City.

Pieces of evidence recovered from the possession and control of the suspect, including the buy-bust item, are listed below:

- a. One (1) heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (Buy-Bust Item);
- b. Two (2) heat-sealed transparent plastic sachets containing white crystalline substance believed to be shabu (possession items);
- c. One (1) piece genuine One Thousand Peso bill (P1,000.00) bearing serial number BM823234 with initial marking “NCN” (marked money);
- d. One (1) unit caliber .38 revolver without serial number;
- e. Four (4) live ammunitions/ cartridges;
- f. One (1) unit Samsung brand android cellular phone color bluegreen;
- g. One (1) piece empty Marlboro cigarette pack color red; and
- h. One (1) piece sling bag color black.

The arrested suspect as well as the pieces of evidence were immediately brought to Digos CPS for recording and for proper disposition. Buy-bust and Possession drug items have an estimated weight of MOL 0.18 grams of suspected methamphetamine hydrochloride or “shabu” with DDB value of One Thousand Two Hundred Twenty-four pesos (Php 1,224.00). Digos CPS is now preparing the pertinent documents for the filing of appropriate charges against the suspect.



On December 10, 2021 at about 3:10 PM at Purok Sampaguita, Brgy. Bato, Sta Cruz, Davao Del Sur joint elements from Sta. Cruz MPS personnel led by **PMAJ CRISALDO R GAILA-COP** together with personnel from PDEA XI Davao Sur led by **Agent Mildred Driz-Romero**, personnel from PDEU led by **PMAJ EDILBERO P CABILLO** and personnel from PIU led by **PLTCOL RAMIL M MACARAMPAT** conducted joint Drug Buy-bust operation covered with PDEA Pre-ops number **30004-122021-0147 @ 1136H**.

Recovered from possession and control of **JHON REY BISQUERA LEGARA** during the buy bust operation were;

- a. one (1) piece small transparent plastic sachet containing crystalline substance believed to be shabu (buy-bust item);
- b. Two (2) pieces small transparent plastic sachet containing crystalline substance believed to be shabu (subject for possession);
- c. Two (2) pieces different identification cards;
- d. One (1) piece One Thousand Peso Bill (Php 1,000.00) bearing serial number AH842827 with initial "CHB" (marked money);
- e. One (1) pc small leather Wallet color brown;
- f. One (1) piece Bros Cigarettes Pack;
- g. One (1) Unit Cellphone touch screen (Samsung); and
- h. Two pieces (1) One Hundred Peso Bill Bearing Serial no. CH355351 and PU637151;

That after the recovery of all pieces of evidence, tagging, marking and inventory were immediately conducted at the crime scene in the presence of Brgy. Kag. Joseph P. Rebuyon of Brgy. Bato, Ramon P Susano Jr- media representative and Rolando D Patos from DOJ. The arrested suspect was identified as certain **JHON REY BISQUERA LEGARA**, male, 27 years old, single, company employee and a resident of Prk. 3 Brgy. Sinayawan, Hagonoy, Davao del Sur and listed in PNP-PDEA Watchlist Regional Target No. 8, High Value Individual. That the recovered drug item has an estimated weight of 0.40 grams with DDB value of Two Thousand Seven Hundred Twenty Pesos (Php 2,720.00). That the arrested suspect is now temporarily under the custody of Sta Cruz MPS for proper disposition.



On December 11, 2021 at about 12:15 AM, MDEU personnel of Sulop MPS led by **PCPT DARRYL FRANCIS N RAMOS**, OIC together with personnel from PDEU under the direct supervision of **PMAJ EDILBERTO P CABILLO**, Chief PDEU, PIU Davao Sur under the direct supervision of **PLTCOL RAMIL M MACARAMPAT**, Chief PIU and 1104<sup>th</sup> MC RMFB 11 under the direct supervision of **PCPT RICHARD P LAPACEROS**, Commanding Officer, conducted a joint buy-bust operation under PDEA coordination number 3004-122021-0168 Time 2222H at P-7 Brgy. Talas, Sulop, Davao del Sur which resulted to the arrest of one **JUFFREY BATAWANG SEVILLA**, Alias "**DINGDONG**", 26 years old, lived-in status and a resident of P-13 Poblacion, Sulop, Davao del Sur. Arrested suspect is categorized as Regional Target No. 10 High Value Individual (HVI).

Recovered from his possession and control were two (2) pieces heat sealed transparent plastic sachet containing white crystalline substance suspected shabu "Possession Items" and One (1) sachet heat sealed transparent plastic sachet containing white crystalline substance suspected shabu "Buy Bust Item" and One (1) piece One Thousand Peso Bill marked money bearing Serial No. KK466821 and Non-Drug Items.



On December 8, 2021 at about 10:30 PM, Malalag MPS MDEU and Intel personnel led by **PCPT JOCYVIEL S ZAMORA**, COP, together with PDEU personnel led by **PMAJ EDILBERTO P CABILLO**, PIU personnel led by **PLTCOL RAMIL M MACARAMPAT**, Chief PIU, with coordination from PDEA led by IA V Mildred Romero, and 1<sup>st</sup> DSPMFC personnel led by **PLT JUNEMAR D PASOBILLO** under direct supervision of **PMAJ LEIF V QUILLILAN**, conducted a joint buy-bust operation at Purok 5, Brgy New Baclayon, Malalag, Davao del Sur, with PDEA RO XI Pre Operation Number 30004-122021-0120 1752H dated 08 December 2021 which resulted in the arrest of HVI- Regional Target no. 10, one (1) **Romeo Margarito Abogan a.k.a**

“**Romeo**,” 43 years old, married, Habal-habal driver and a resident of Purok 6, Brgy New Baclayon, Malalag, Davao del Sur.

Pieces of evidence recovered as a result of the operation are as follows:

- a) One (1) small heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (Subject for buy-bust);
- b) One small heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (possession item);
- c) One (1) piece Five Hundred Peso bill (P500.00) with serial no. JT669654 with marking JMF (mark money);
- d) One (1) piece One Hundred Peso bill (P100.00) with serial no. FW327099;
- e) One (1) Ten Peso coin; and
- f) One (1) One Peso coin

The arrested suspect as well as the pieces of evidence was immediately brought to Malalag MPS for recording and for proper disposition and will subsequently be brought to Davao Sur Provincial Crime Laboratory (DSPCLO) located at Magsaysay St., Digos City for laboratory and drug test examination.

Seized drug item have an estimated weight of MOL 0.3 grams of suspected methamphetamine hydrochloride or “shabu” with DDB value of One Thousand Forty Pesos (Php 1,040.00).

Almendras District, Padada, Davao del Sur under PDEA pre-ops number 30004 122021 0127 1650H which resulted in the arrest of one **JOHN PATRICK MANDIGO ELESTERIO**, 29 years old, male, married and a resident of Purok 2, Brgy Tagansule, Malalag, Davao del Sur.

Confiscated from the possession and control of said suspect were the following:

- a. One (1) pc heat sealed transparent plastic sachet containing white crystalline substance believed to be Shabu with markings and initials “OZO” (for buy-bust);
- b. Three (3) pcs heat sealed transparent plastic sachet containing white crystalline substance believed to be Shabu with markings and initials “RCT-1, RCT 2 and RCT-3” (for possession);

- c. One (1) pc One Thousand Peso Bill (P1,000. 00) bearing serial number XV284317 with marking "OZO" in left portion (marked money);
- d. One (1) unit OPPO A5s cellular phone color blue with sim card inserted;
- e. Five (5) pcs One Hundred Peso Bill; and
- f. One (1) pc color blue disposable lighter.

The arrested suspect as well as the pieces of evidence was immediately brought to Padada MPS for recording and for proper disposition and will subsequently be brought to Davao Sur Provincial Crime Laboratory (DSPCLO) located at Magsaysay St., Digos City for laboratory and drug test examination.

Total confiscated/seized drugs from the said suspect have an estimated National Approved Value of Six Thousand Eight Hundred Pesos (P6,800) weighing MOL 1 gram.

The arrested suspect and the confiscated items are now in the custody of Padada Municipal Police Station and Violation of R.A. 9165 is being prepared against the suspect.

### Campaign Against Illegal Gambling



On December 11, 2021 at around 1:01 PM, Intel, CDEU and Warrant personnel of Digos CPS led by **PLT DIOSDADO S NIONES II** together with 1<sup>st</sup> DSPMFC led by **PLT JUNE MAR D PASOBILLO** and **PHPG** under the direct control and supervision of **PLTCOL HAMLET M LERIOS**, OIC, conducted joint Anti-Illegal Gambling Operation (Illegal Cockfighting) at Sitio Palma, Brgy. Tres de Mayo, Digos City that resulted in the arrest of the following suspects:

- a. **Julius Revilla Sarador**, 26 years old, male, self-employed and a resident of Purok 7, Brgy San Agustin, Digos, City;
- b. **Adonis Palma Elesterio**, 32 years old, male, self-employed, and a resident of Sitio Palma, Brgy Tres de Mayo, Digos City; and
- c. **Alfredo Tamayo Bucol**, 64 years old, male, driver and a resident of Purok Manggahan, Brgy. Tres de Mayo, Digos City;

The aforementioned suspects were caught in the act of engaging an illegal gambling activity (Illegal Cockfighting) at the above stated place. Recovered from their possession and control were the following:

- c. Three (3) dead fighting cocks; and
- d. Five (5) live fighting cocks.

- d) One (1) pc ballpen;








- e) One (1) pc Php 100.00 peso bill bearing SN CV776706 for the bet number 22 and 03; and

Confiscated pieces of evidence as well as the suspect is now under the custody of said station for proper disposition.







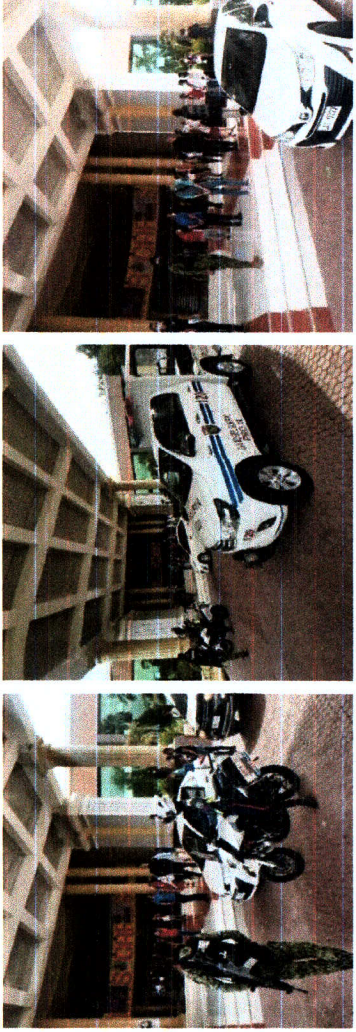
#### **Visit of H.E. Finland Ambassador Juha Pyyko and Party at the Provincial Governor's Office**

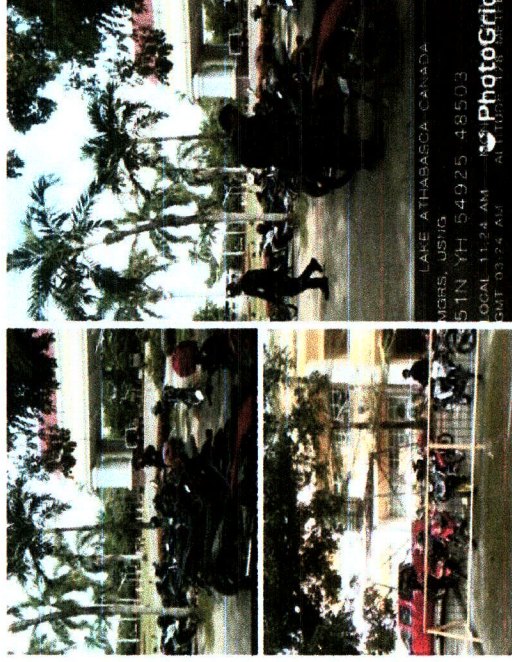
