EXECUTIVE ORDER NO. 06

AN ORDER ENJOINING ALL CITY/MUNICIPAL LOCAL GOVERNMENT UNITS TO MOBILIZE THEIR LOCAL EMERGENCY OPERATION CENTERS FOR CORONA VIRUS-19 (COVID-19) VACCINATION CAMPAIGN

WHEREAS, Administrative Order No. 2021-0005, the Subject: National Strategic Policy Framework for COVID-19 Vaccine Deployment and Immunization” which shall provide a strategic policy guidelines and directions on the selection, access, deployment of COVID 19 vaccine and the COVID-19 Vaccination Campaign. Specifically, the Administrative Order shall provide guidance on vaccine delivery, acceptance, human resource management and training, supply chain and management of health care waste, safety and surveillance and immunizations of monitoring teams. Further, to guide the implementation and provision of a free, safe and effective, high quality of vaccine against SARS-COV 2 and to ensure implementation of risk communications, health education, community engagement activities utilizing diverse platforms and the conduct of strategies and interventions addressing vaccine hesitancy.

WHEREAS, the scope and coverage of Administrative Order No. 2021-0005 is to apply to the Inter-Agency Task Force in the Management of Emerging Disease (IATF) and National Task Force on COVID-19 down to the Local Counterparts, academe, implementing sectors and agencies, immunization program managers, service providers, immunization partners and the private sectors, among others.

WHEREAS, in the advent of actual immunization there may be Adverse Effects Following Immunization (AEFI), a situation where any untoward medical occurrence which follows immunization and which does not necessarily have causal relationship with the usage of the vaccine. The adverse event may be any unfavorable or unintended sign which may need immediate referral and transport to a nearest or higher facility for proper evaluation and management.

WHEREAS, the national organizational structure, the COVID-19 Vaccine Cluster, is complemented with the activation of an Incident Command System (ICS), which is supported by an operations center, duly named as the Local COVID-19 Vaccine Emergency Operations Center.

NOW THEREFORE, I DOUGLAS RA CAGAS, LLB, MNSA, MBE, Governor of the Province of Davao del Sur, by virtue of the powers vested in me by existing laws, do hereby **ORDER** all City/Municipal Local Government Units, to mobilize their local emergency operations center for Corona Virus-19 (COVID-19) Vaccination Campaign which shall be led by the Local Government Units. The Provincial Vaccinations Emergency Operations Center shall oversee the Municipal and City Vaccination Emergency Operations Center. The COVID-19 Vaccination Emergency Operations Center shall compose of various teams, namely:

1. Planning, Campaign Management and Technical Team
 - CHO/MHO, PDOHO, DILG, MSWD, DepEd, AFP
2. Finance, Cold Chain and Logistics Team
 - CHO/MHO, PDOHO, CDRRMO/MDRRMO, AFP
3. Coordination Team
 - CHO/MHO, PDOHO, CDRRMO/MDRRMO, DILG
4. Vaccine Safety, Surveillance and Response Team
 - CHO/MHO, PDOHO, DILG
5. Communications, Advocacy and Partnership Team
 - CHO/MHO, PDOHO, CIO/MIO

The implementing units such as government and private hospitals, private clinics, government agencies and rural health units shall forward all concerns and reports to the City/Municipal Health Offices. The City/Municipal Health Offices, in turn, are required to report all concerns and updates to the Provincial VEOC. The overseeing VEOC, on the other hand, shall provide feedback and recommendation/s to the reporting VEOC.

This Order shall take effect immediately.
