**EXECUTIVE ORDER NO.** 02

**AN ORDER CREATING THE PROVINCIAL FISHERY LAW  
ENFORCEMENT TEAM (PFLET) OF DAVAO DEL SUR**

**WHEREAS**, as provided for in Sub-paragraph (2) of Paragraph (b) of Section 465, Article 1 of Chapter 3 of R.A 7160, otherwise known as the Local Government Code of 1991, which states, to wit: to enforce all laws and ordinances relative to the governance of the province and the exercise of the appropriate corporate powers as provided for under Section 22 of this Code, to implement all approved policies, programs, projects, services and activities of the province and in addition to the foregoing shall issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

**WHEREAS**, Section 124 of the Republic Act No. 8550 as amended by R.A 10654, the law enforcement agencies, the Philippine National Police (PNP), the Maritime Command, Philippine Coast Guard, Deputized Law Enforcers of the LGU's and/or other law enforcement agencies are hereby authorized to enforce the Fishery Laws, Rules and Regulations and the Local Ordinances in collaboration and coordination with the Fisheries Aquatic Resource Management Council (FARMC).

**WHEREAS**, there is a need to create a Provincial Fishery Law Enforcement Team (PFLET) in this province to ensure the protection, conservation, and management of the fishery and aquatic resources;

**NOW THEREFORE, I, MARC DOUGLAS IV CHAN CAGAS**, Provincial Governor of Davao del Sur by virtue of the powers vested in me by the law, do hereby order;

**SECTION 1. CREATION.** The Provincial Fishery Law Enforcement Team (PFLET) is hereby created in accordance with R.A. 8550 series of 1998 as amended by R.A. 10654.

**SECTION 2. COMPOSITION.** The Provincial Fishery Law Enforcement Team shall be composed of the following agencies/office to wit:

**SECTION 3. FUNCTIONS.** The Provincial Fishery Law Enforcement Team shall have the following functions:

- a. To formulate plans, programs and activities for the effective enforcement of fishery laws in the province;
- b. To conduct information, education and communication campaign to all municipalities and component city of the province;
- c. To conduct seaborne and foot patrol in the area of responsibility on a regular basis;
- d. Apprehend violators of fishery laws, rules, and regulations;
- e. Prosecute cases in coordination with the Provincial and City Prosecutors;
- f. Coordinate with the C/MFLET in the enforcement of fishery laws.

**SECTION 4. BUDGETARY ALLOCATION.** The Provincial Government shall allocate a regular annual budget as administrative support for the mobilization and operation of the PFLET.

**SECTION 5. SEPARABILITY CLAUSE.** Should any provision of the order be deemed invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. REPEALING CLAUSE.** All previous issuances of the province which are consistent with this Order are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.** This order shall take effect immediately.








