## **WEEKLY ACCOMPLISHMENT REPORT**

(Period Covered: February 7-13, 2022)

### **Campaign Against Illegal Drugs**



On February 10, 2022 at about 08:17 AM, personnel from Provincial Drug Enforcement Unit (PDEU) and Provincial Intelligence Unit (PIU) led by PMAJ EDILBERTO P CABILLO, Chief, PDEU, PDEA DAV SUR led by IAV MILDRED DRIZ-ROMERO, Provincial Officer, RID XI led by PMSg Frankie Ellazo, RMFB 1104<sup>th</sup> led by PCPT RICHARD P LAPACEROS, CDEU led by PLTCOL HAMLET M LERIOS, COP Digos CPS conducted a joint Anti-illegal Drug Buy-bust operation with reference number **PDEA RO XI Pre Operation Number 30004-022022-0166** at Purok 4 Brgy Aplaya, Digos City under the over-all supervision of PLTCOL RAMIL M MACARAMPAT, Chief PIU. The subject of buy bust operation was **LEISTHER SARDIDO @Pawpaw (At-Large)** eluded arrest after sensing that he was transacting an operative, but his cohorts was arrested and later recognized as; **JAY KAISER ALMACIN DIAMAD @Bonbon**, male, 25 years old (November 25, 1996), single and presently residing at Purok 4, Brgy Aplaya, Davao del Sur Regional Target 7 (High Value Individual).

Pieces of evidence recovered from the possession and control of the suspects are;

- One (1) pc heat sealed transparent plastic sachet containing
- crystalline substance believed to be shabu (Buy-Bust Item);

- Three (3) pcs heat sealed transparent sachet containing crystalline
- substance believed to be shabu (possession item);
- Two (2) pcs improvised foil strip with residue
- Four (4) pcs improvised tooter
- Two (2) pcs disposable lighter, one lighter with needle attached; and
- One (1) pc VIVO box;

The arrested suspect as well as the pieces of evidence listed above were brought to the office of PDEA Davao del Sur for proper disposition.

The arrested suspect will be brought to Davao del Sur Provincial Hospital (DSPH) for medical examination. The seized drug evidence together with the arrested suspect will be brought to PDEA Regional Office XI, located at Camp. Capt. Domingo E. Leonor, San Pedro, Davao City for the quantitative/qualitative and drug test examination.

Buy-bust and possession drug items have an estimated weight of MOL 12 grams of suspected methamphetamine hydrochloride or shabu with an estimated DDB value of Eighty One Six Hundred Thousand Pesos (Php 81,000.00).

PDEA DAV SUR and PDEU are now preparing the pertinent documents for the violation of Sec. 5,11 and 12 Article II of RA 9165. Investigator on case is Alexander S Mamac-09693330169/ PSSGg Brian T Dahinog-09338295563.



On February 10, 2022 at about 2:44 PM, personnel from City Drug Enforcement Unit (CDEU) and Intelligence Unit of Digos City Police Station led by **PLT ARTURO P PAPAS JR**, CDEU/Intel Officer conducted a joint Anti-illegal Drug “Buy-bust” operation **PDEA RO XI Pre Operation Number 30004-022022-0185** at Purok Madasigon, Brgy. San Jose, Digos City together with the personnel from PDEU,PIU, RIU, PIT and PDEA Davao del Sur under the over-all supervision of **PLTCOL HAMLET M LERIOS**, Acting Chief of Police, Digos City Police Station which resulted in the arrest of **DANILO CAÑEDO BAROTA alias ONTOT**, 28 years old, male, single, laborer and a resident of Purok Pag-asa, Roxas St., Brgy Zone 2, Digos City.

Pieces of evidence recovered from the possession and control of the suspect, including the buy-bust item, are listed below:

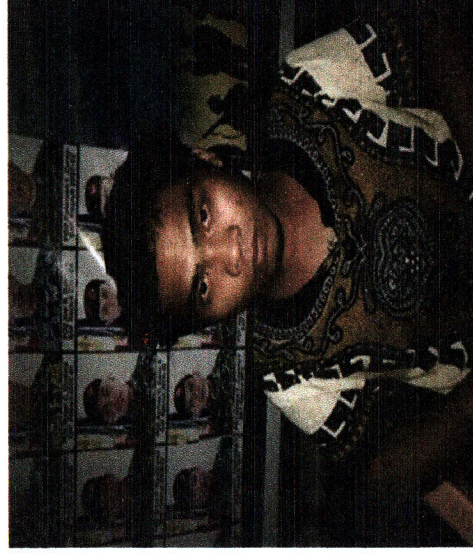
- a. One (1) pc. heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (Buy-bust item);
- b. Two (2) pcs. heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (possession items);
- c. One (1) pc. genuine One Thousand Peso bill (P1,000.00) bearing serial number ES603648 with initial marking "SBD" (marked money);
- d. One (1) pc. plastic disposable lighter color green;
- e. One (1) pc. CTTS card;
- f. One (1) pc. Small pouch/coin purse color blue;
- g. One (1) unit Samsung keypad cellphone color white; and
- h. One (1) unit Honda CRF 150 with chassis no. MH1KD1270LK031586 color black with attached temporary plate no. 365 LOR, with ignition key.

The arrested suspect as well as the pieces of evidence listed above were immediately brought to Digos CPS and presented to the duty desk officer for recording and for proper disposition.

The arrested suspect will be brought to Davao del Sur Provincial Hospital (DSPH) for medical Examination. The seized drug evidence together with the arrested suspect will be brought to Davao Sur Provincial Forensic Unit (DSPFU) located at Magsaysay St., Digos City for the conduct of laboratory and drug test examination, respectively.

Buy-bust and Possession drug items have an estimated weight of MOL 0.54 grams of suspected methamphetamine hydrochloride or "shabu" with estimated DDB value of Three Thousand Six Hundred Seventy Two pesos (Php 3,672.00).

Digos CPS is now preparing the pertinent documents for the filing of appropriate charges against the suspect. Investigator-On-Case – PSSg Joyce Chrysler D De Jesus with CP# 09488133349. For information and progress report will follow.



On February 11, 2022, at about 4:34 am, personnel from Digos City Police Station led by **PLT MARICAR M OTOC**, Officer of the Day under the supervision of **PLTCOL HAMLET M LERIOS**, Officer-in-Charge conducted patrolling at Jose Abad Santos St., Brgy Zone 3, Digos City which resulted to the arrest of **MOAMAR MACAPODI MACALABA**, male, 21 years old, Single, pedicab driver and a resident of Quirino Avenue, Brgy. Tres de Mayo, Digos City who was caught in the act violating RA 9165 at above-mentioned address.

Pieces of evidence recovered from the possession and control of the above suspect are the following:

Seized drug item have an estimated weight of MOL 0.93 grams of marijuana dried leaves with estimated market value of Thirty pesos (Php 30.00).

### Accomplishments on Anti Illegal Logging-2



On February 8, 2022 at about 3:00 PM, Sta Cruz MPS personnel led by PSMS Arnold Badua Intel/PNCO under the direct supervision of PMAJ KRISTINE M MIRAÑA together with CIDG field unit led by PLTCOL. DEMETRIUS E TAYPIN and DENR-CENRO Digos conducted joint operation at Brgy. Zone 2, Sta Cruz, Davao Del Sur, in relation to OPLAN KALIKASAN (Campaign against Unlawful Destruction of Natural Resources) that resulted in the arrest of the suspect identified as Richard Pasaforte Dagandan, 45 years old, male, single, driver/laborer and a resident of Purok Talisay, Brgy. San Jose, Digos City, after he was caught from his possession and control Gmelina lumbers not authorized by law.

Confiscated evidence from the suspect are the following to wit: thirty-four pieces (34 pcs) Gmelina Lumbers approximate length 302.34 board feet with estimated market value of nine thousand six hundred seventy-four point eighty-eight pesos (Php 9,674.88).

On February 7, 2022 at about 4:00 PM, this station received an information regarding an illegal cutting of gmelina trees at P-2, Dapok, Kiblawan, Davao del Sur. Immediately personnel of Kiblawan MPS together with the Intel operatives went to the reported area to validate the said report and for possible apprehension of the individuals involved. Upon arrival of the responding personnel to the area which was uninhabited and close to a river bank, the individuals present at the said area immediately ran towards Brgy. Buguis, Sulop crossing the river leaving the fresh cut gmelina woods behind. Responding personnel tried to chase but failed to apprehend the said individuals due to the heavy current of the river.

No body claimed to be the owner of the said gmelina woods and the identities of the individuals who were present at the area and were able to run away upon arrival

of the responding police officers were not determined. Responding police officers confiscated the fresh cut gemelina woods with a volume of more or less 300 board feet. About 7:00 PM of the same date, responding personnel arrived to Kiblawan MPS and the said wood is now under the custody of this station for proper disposition.

Confiscated during the operation were the following to wit:



- a. One (1) piece small heat sealed transparent plastic sachet containing white crystalline substance believed to be shabu (subject for buy bust);

- d. One (1) piece One Hundred Peso bill; and
- e. One (1) unit OPPO cellphone.

The arrested suspect is now under the custody of Bansalan MPS in the case for violation of Republic Act 9165 is being prepared for filing in court against the suspect. Seized drug item have an estimated weight of MOL 0.147 grams of suspected shabu with DDB value of One thousand Pesos (Php 1000.00).




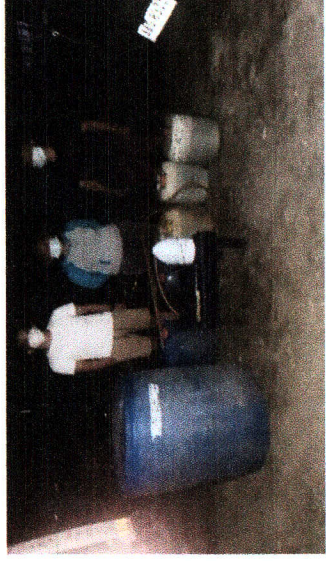
### Campaign Against Loose Firearm
