1. The Provincial Government of Davao del Sur, through the General Fund to apply the sum of ₱ 850,000.00 being the ABC to payments under the contract for IB No. G-387-22 (PHO). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Davao del Sur now invites bids for the above Procurement Project. Delivery of the Goods is required by 10 calendar days. Bidders should have completed, for the last 3 years from the date of submission and receipt of bids, a contract similar to the Project. 6. Origin of Goods

Framework Agreement, or fails to furnish the performance security or performance securing declaration.
