- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- Bidders should possess a valid PCAB License applicable to the above-type and cost of the contract, and should meet the other eligibility requirements stated in the eligibility documents.
- 5. The documents required in the eligibility documents shall be submitted as part of the technical documents of the bidders as provided in the Instructions to Bidders. Eligibility/Technical and Financial documents must be book bound and properly tab at right side in three copies (Original, Copy 1 and Copy 2), respectively. Any document submitted, not book bound shall be rejected outright. For the Financial Proposals not exceeding ten (10) pages may be book bound or securely stapled.

Only bidders who purchased the Bidding Documents with corresponding official receipt of the bidding documents will be allowed to submit bids (ITB 6.8).

Bids must be delivered to Ralota Hall of the Douglas Ralota Cagas Sports Complex and Business Center (Coliseum), Barangay Matti, Digos City, Davao del Sur on or before March 8, 2022 at 9:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 9. Bid opening shall be on March 8, 2022, 9:00 a.m. at Ralota Hall of the Douglas Ralota Cagas Sports Complex and Business Center (Coliseum), Barangay Matti, Digos City, Davao del Sur.
