- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventyfive percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- Bidders should possess a valid PCAB License applicable to the above-type and cost of the contract, and should meet the other eligibility requirements stated in the eligibility documents.
- 5. The documents required in the eligibility documents shall be submitted as part of the technical documents of the bidders as provided in the Instructions to Bidders. Eligibility/Technical and Financial documents must be book bound and properly tab at right side in three copies (Original, Copy 1 and Copy 2), respectively. Any document submitted, not book bound shall be rejected outright. For the Financial Proposals not exceeding ten (10) pages may be book bound or securely stapled.
