





#### 1. WHAT IS THE COVID-19 VACCINE ASTRAZENECA?

The COVID-19 Vaccine AstraZeneca is an investigational drug that is currently being studied in phase III clinical trials. The FDA Philippines has authorized its emergency use to prevent COVID-19 in individuals 18 years of age and older under an Emergency Use Authorization (EUA).

# 2. WHAT IS AN EMERGENCY USE AUTHORIZATION (EUA)?

EUA is an authorization issued for unregistered drugs and vaccines in a public health emergency. The EUA is not a Certificate of Product Registration (CPR) or a marketing authorization.

Because of the COVID-19 pandemic, the FDA Philippines has made the COVID-19 Vaccine AstraZeneca available for emergency use under an EUA. It has not undergone the same type of review as an FDA-approved or cleared product. An EUA may be issued when certain criteria are met, which includes that there are no adequate, approved, available alternatives. It was also based on the scientific evidence available showing that the vaccine may be effective to prevent COVID-19 during the COVID-19 pandemic, and that the benefits of the vaccine outweigh the risks.

# 3. WHO SHOULD GET COVID-19 VACCINE ASTRAZENECA?

FDA Philippines has authorized the emergency use of the COVID-19 Vaccine AstraZeneca in individuals 18 years of age and older.

# 4. WHO SHOULD NOT COVID-19 VACCINE ASTRAZENECA?

You should not get the COVID-19 Vaccine AstraZeneca if you had a severe allergic reaction after a previous dose of this vaccine. Seek consultation with your Physician or healthcare providers regarding your queries and concerns.

# 5. WHAT SHOULD YOU MENTION TO YOUR VACCINATION PROVIDER BEFORE YOU GET THE COVID-19 VACCINE ASTRAZENECA?

Tell your vaccination provider if you have any (1) allergies, (2) bleeding disorder or are currently on a blood thinner, (3) Symptoms like fever, colds, cough,

sore throat, etc, (4) History of exposure to a confirmed or suspected COVID-19 case in the past two weeks, (5) Previously treated for COVID-19 in the past 90 days, (6) Pregnant or plan to become pregnant, (7) Breastfeeding, (8) Received any vaccine in the past 2 weeks, (9) Immunocompromised or are currently on/have been in the past six months on a medicine that affects your immune system.

Depending on the results of the health screening by your vaccination provider, your vaccination might get deferred to another date, or you might be required a medical clearance from your Attending Physician before you'll be allowed to get the vaccine.

#### 6. HOW IS THE COVID-19 VACCINE ASTRAZENECA GIVEN?

The vaccine will be given to you as an injection into the muscle. The vaccine will be given in 2 doses given 4-12 weeks apart. If you receive one dose of the COVID-19 Vaccine Astrazeneca, you should receive a second dose of this same vaccine 4-12 weeks later to complete the vaccination series.

# 7. WHAT ARE THE BENEFITS OF COVID-19 VACCINE ASTRAZENECA?

COVID-19 Vaccine AstraZeneca stimulates the body's natural defense (immune system). It causes the body to produce its own protection (antibodies) against the virus. This will help to protect (70.4% efficacy against symptomatic COVID-19, 14 days after the second dose) you against COVID-19 in the future. The duration of protection against COVID-19 is currently unknown. This is not a live virus and cannot cause a person to get COVID-19.

# B. WHAT ARE THE RISKS OF COVID-19 VACCINE ASTRAZENECA?

Side effects that have been reported include: (1) injection site tenderness, pain, warmth, redness, itching or swelling (2) generally feeling unwell, (3) feeling tired (fatigue), (4) chills or feeling feverish, (5) headache, (6) feeling sick (nausea), (7) joint pain or muscle ache, (8) fever.
