



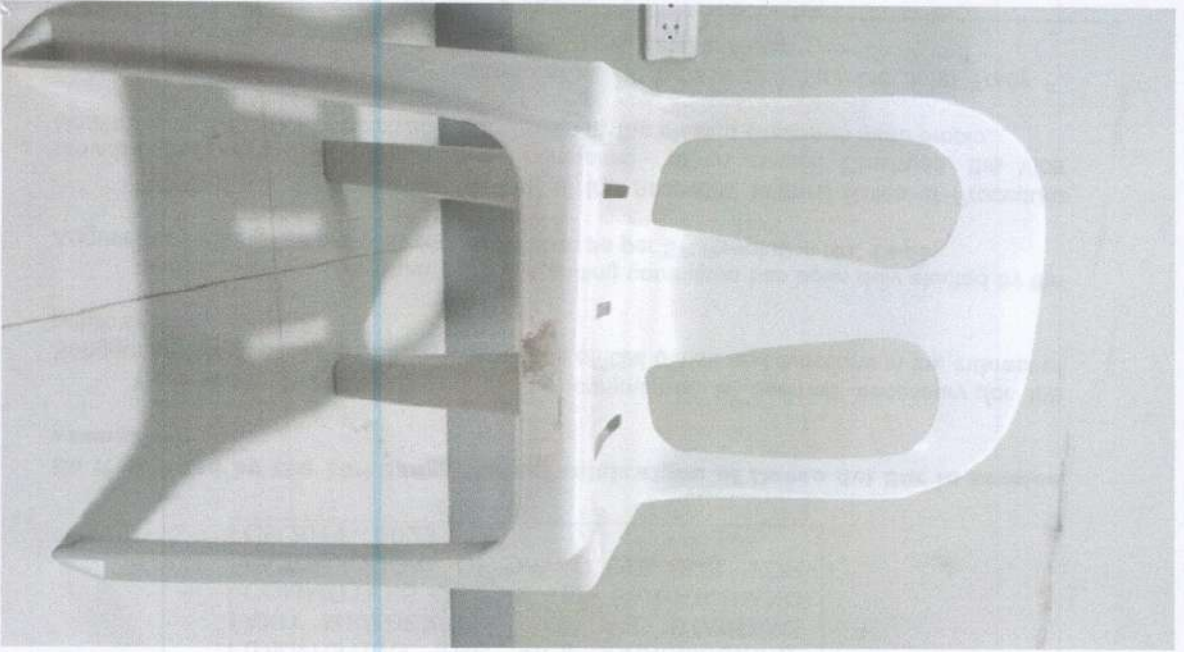


Figure 1: Front view of the chair showing a stain on the seat.

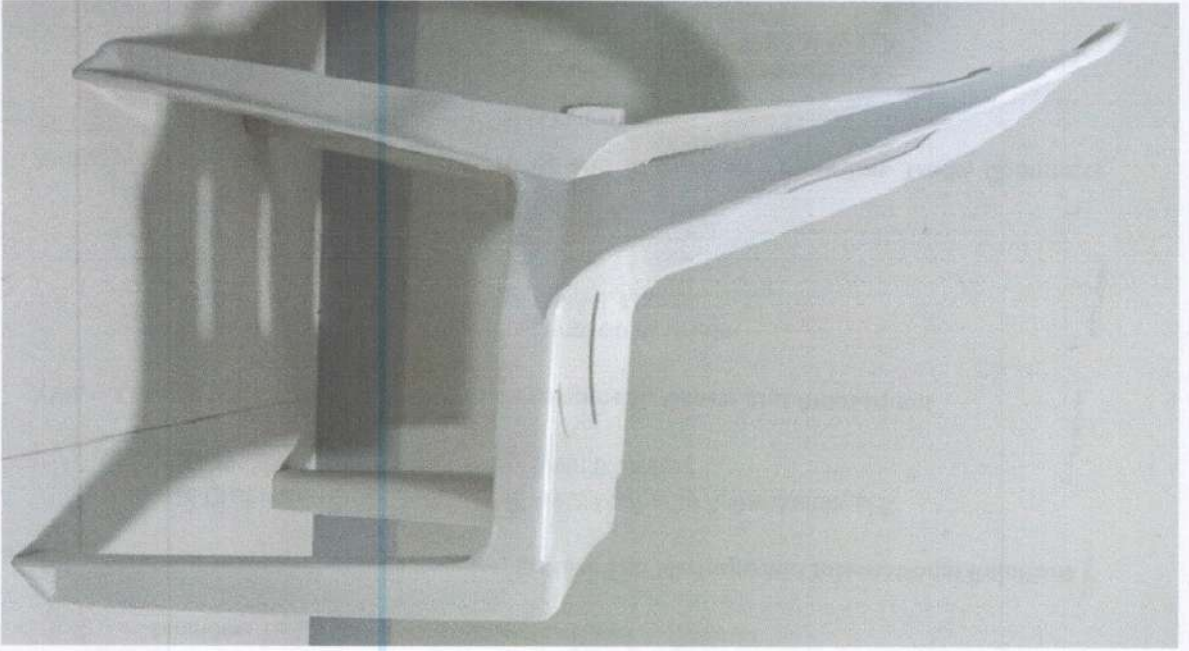


Figure 2: Side view of the chair.

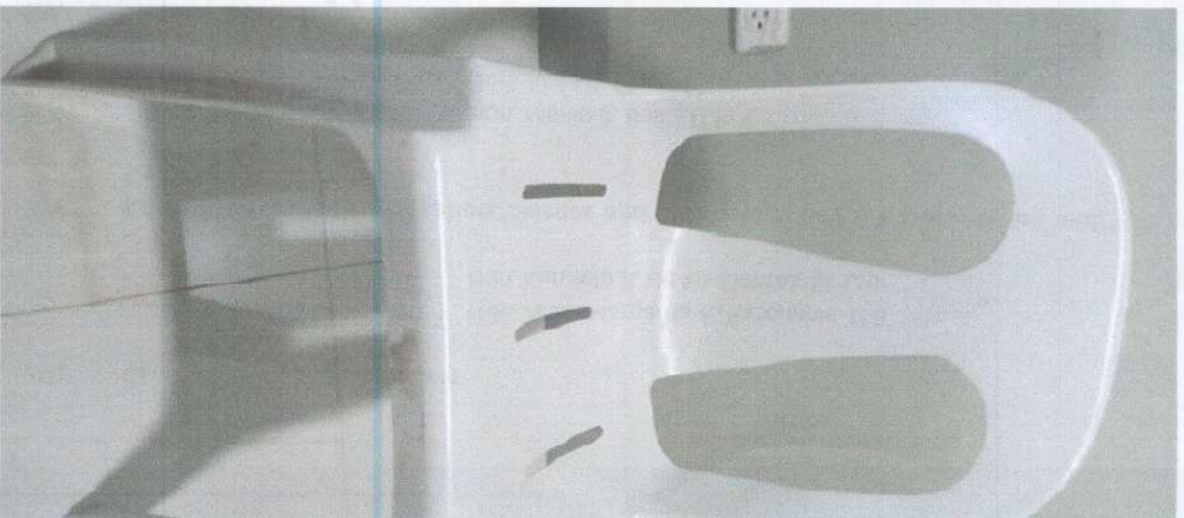


Figure 3: Close-up front view of the chair.

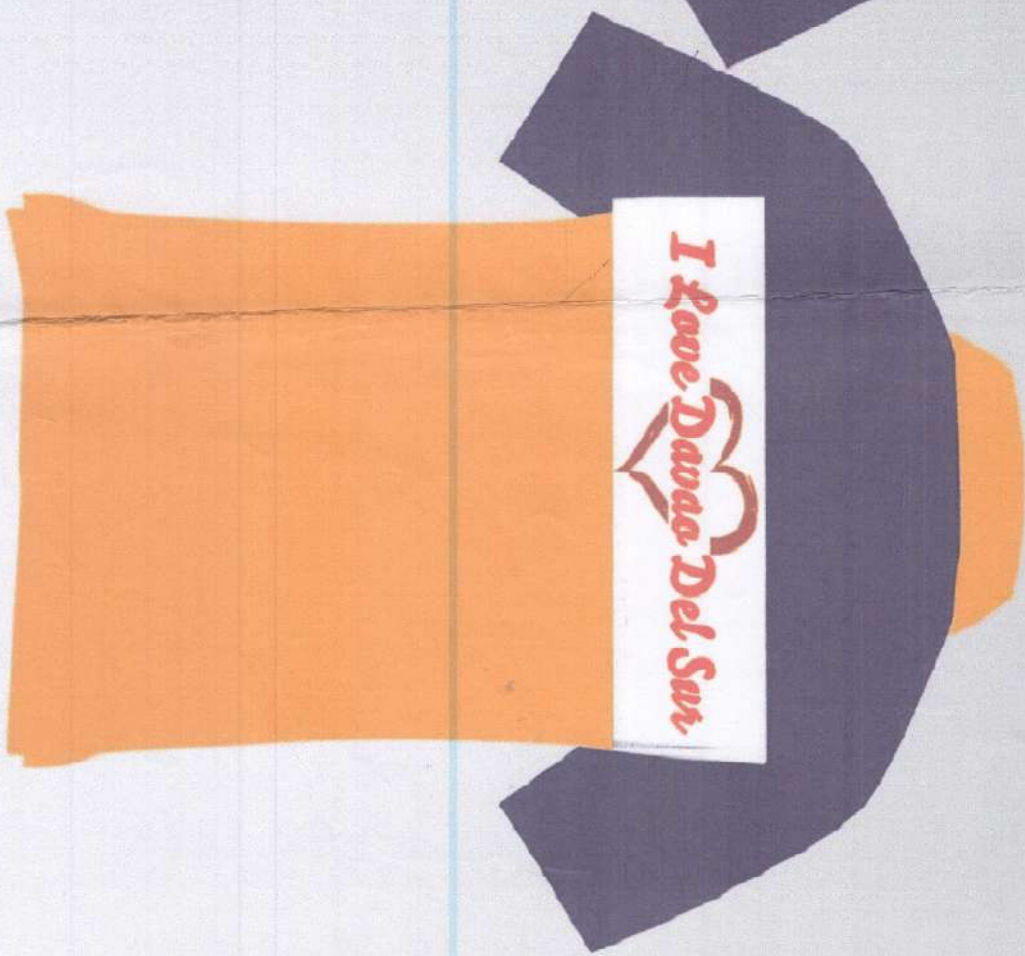
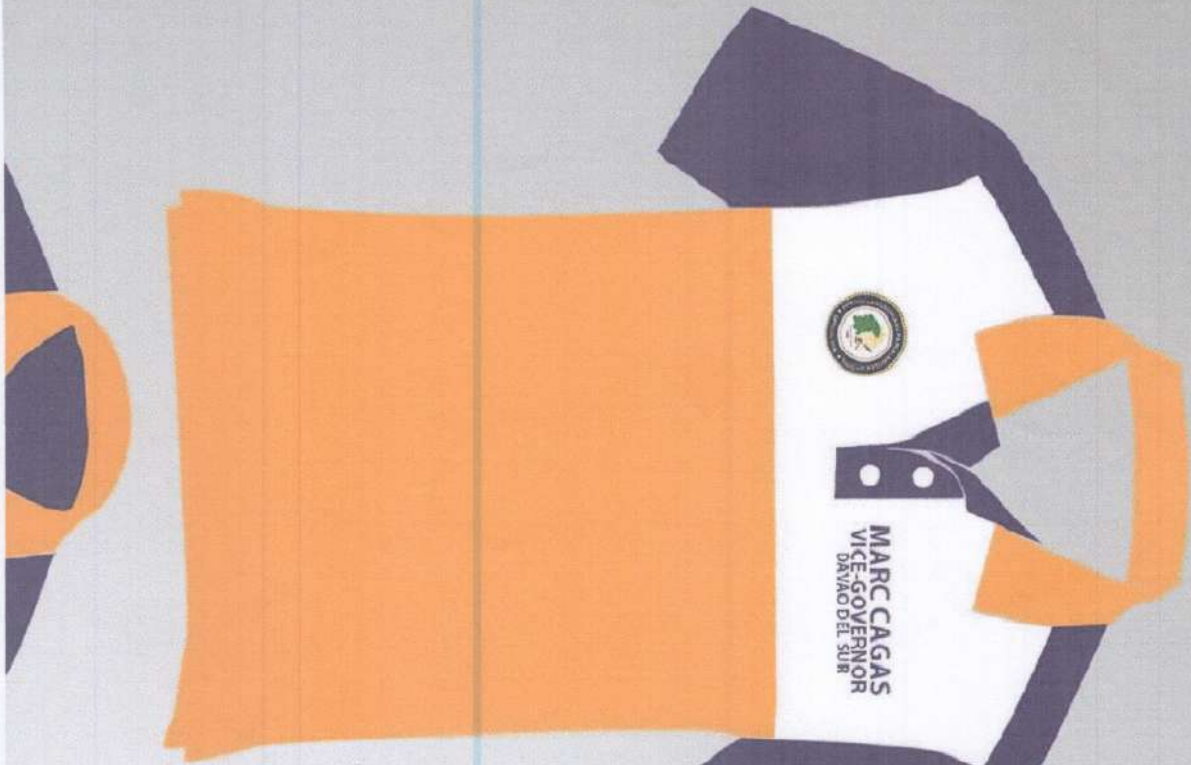
