



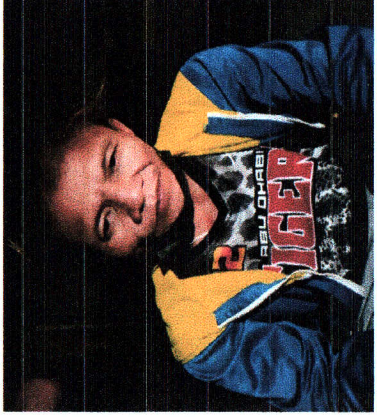

WEEKLY ACCOMPLISHMENT REPORT

(Period Covered: January 31-February 6, 2022)

Campaign Against Illegal Drugs



On February 3, 2022 at about 12:14 AM personnel from City Drug Enforcement Unit (CDEU) and Intelligence Unit of Digos City Police Station conducted a joint Anti-illegal Drug “Buy-bust” operation with PRE-OPS number 30004-022022-0025 at Purok 10, Christian Village, Brgy. Aplaya, Digos City together with the personnel from, PIT, PDEU, PIU, 1st DSPMFC and PDEA Davao del Sur under the over-all supervision of PLTCOL HAMLET M LERIOS, Officer-In-Charge, Digos City Police Station which resulted in the arrest of **Alexander Dotdot Ramos** alias “Mak Mak”, male, 51 years old, single (with live-in partner), painter and presently residing at Chapter 2, Brgy. Aplaya, Digos City;

Pieces of evidence recovered from the possession and control of the suspect, including the buy-bust item, are listed below:

- a. One (1) pc. heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (Buy-Bust Item);
- b. Two (2) pcs. heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (possession items);
- c. One (1) piece genuine One Thousand Peso bill (P1,000.00) bearing serial number XE694951 with initial marking “JAN” (marked money);
- d. One (1) piece coin purse color black; and
- e. One (1) pc. genuine Five Hundred Peso bill (P500.00) bearing serial number AY 126286

The arrested suspect as well as the pieces of evidence listed above were immediately brought to Digos City Police Station for recording and for proper disposition.

The arrested suspect will be brought to Davao del Sur Provincial Hospital (DSPH) for medical examination. The seized drug evidence together with the arrested suspect will be brought to Davao Sur Provincial Forensic Unit (DSPFU) located at Magsaysay St., Digos City for the laboratory and drug test examination.

Buy-bust and Possession drug items have an estimated weight of MOL 0.29 grams of suspected methamphetamine hydrochloride or "shabu" with an estimated DDB value of Four Thousand Three Hundred Fifty Pesos (Php 4,350.00).

Digos City Police Station is now preparing the pertinent documents for the filing of appropriate charges against the suspect. Investigator on case is PSSGg Wenifredo B Baga-an Jr with with contact number 09079264742.



On February 3, 2022 at about 5:20 AM, a confidential informant arrived at Sta Cruz MPS divulged and stated that alias "BESH" is peddling illegal drugs known as "Shabu" at Lubo, Brgy Zone-I, Sta Cruz, Davao del Sur.

Immediately, Sta. Cruz MPS personnel led by PSMS Arnold Badua, Intel PNCO under the direct supervision of PMAJ KRISTINE M MIRAÑA-OIC, PDEU personnel led by PCAPT EDILBERTO P CABILLO, PIU led by PLTCOL RAMIL MACARAMPAT, RIU 11 led by PLT RON BILLY C. IBAÑEZ, 1104th MC, RMFB XI led by PCPT RICHARD P. LAPACEROS and PDEA-11 led by Agent Mildred Driz Romero, conducted Drug Buy-bust operation under PDEA Pre-ops number 30004-022022-0038.

At about 9:20 AM of same date, said buy bust operation has been consummated that resulted to the arrest of the suspects identified as **Keycel Nelmida Abeco**, alias **Besh**, 26 years old, single, businesswoman, a resident of Lubo, Brgy Zone-I, Sta Cruz, Davao del Sur and **Dominador Cerdan Damian**, 50

years old, married, jobless and a resident of Sitio Malusing, Brgy. Zone-I, Sta Cruz, Davao del Sur and was listed as High Value Individual (HVI), Regional Target no.10.

Recovered from possession and control of alias Besh were; three (3) pieces heat sealed transparent plastic sachet containing white crystalline substance believed to be “SHABU” wrapped in a small piece of white paper (Subject for possession).

Further, recovered from possession and control of Dominador Cerdan Damian were; One (1) piece heat-sealed transparent plastic sachet containing white crystalline substance believed to be “SHABU” (Subject for buy bust) and two (2) pieces heat-sealed transparent plastic sachet containing white crystalline substance believed to be “SHABU” that were placed inside the empty pack of Marlboro red (Subject for possession) with estimated total weight of **0.815 gram** and estimated street value of Seven Thousand and Nine Pesos (**Php 7,009.00**), and One (1) piece One Thousand Peso Bill (PHP 1,000.00) bearing SN DV122418 with initial “VJB” inside the central bank logo of the said bill (Buy Bust Money).

Moreover, the operation was conducted with the presence of Brgy. Captain Ricky D. Taylaran of Brgy. Zone-I, Sta Cruz, Davao del Sur, Ramon P Susano Jr- media representative and Rolando D Patos from DOJ.





The arrested suspects were identified as Keycel Nelimida Abeco alias Besh, female, 26 years old, single, businesswoman and Dominador Cerdan Damian, 50 years old, married, jobless, all residents of Brgy. Zone-I, Sta. Cruz, Davao del Sur.

The arrested suspects were appraised of their constitutional rights provided under the law and now temporarily under the custody of Sta Cruz MPS for proper disposition while the recovered drug items were turned over to Davao Sur Provincial Forensic Unit (DSPFU), Digos City for laboratory examination. Likewise, the arrested suspects were also brought to DSPFU for Urine Test Examination and for medical examination. Investigator on case is PSSg Gil Abe with contact number 09099518910.






