**MEMORANDUM ORDER**

**TO :** ALL CONCERNED NATIONAL GOVERNMENT OFFICES (NGAs), PROVINCIAL GOVERNMENT OFFICES AND ITS INSTRUMENTALITIES

**SUBJECT :** OBSERVANCE OF THE EARTH DAY 2022

**DATE :** April 11, 2022

In the observance of the Earth Day 2022, with the theme “**INVEST IN OUR PLANET**”, the Province of Davao del Sur will initiate a **Clean-Up Drive** inside and outside the **Provincial Capitol and Davao del Sur Coliseum Premises** on **April 21, 2022** based on the following schedules, to wit:

**1. April 21, 2022- 8:00 AM to 12:00 NN.** Clean-up inside Offices to remove office trashes and all possible habitats of rodents and other vermins (annoying insects, etc. ). Segregation of different solid wastes like recyclable, compostable, residual and special waste must be observed before disposal at the Capitol's Materials Recovery Facility (MRF) near the PENR Office.

**2. April 21, 2022- 2:00- 4:00 PM.** Clean-up within the Capitol and Coliseum Grounds (please see area of assignments).

In view of this, the National Government Agencies (NGAs) inside the Provincial Capitol and the Provincial Government Offices and its Instrumentalities shall undertake the above-mentioned activity on their respective premises.

Please send 10-15 participants and bring the following: **brooms (walis tingting), trash bags, dust pans, gloves and bolos.**

Only **recyclable (plastic bottles, glass bottles) and residual wastes** (shopping bags, dirty plastic bottles, soiled rugs, used face masks and other similar items) shall be collected. In the Capitol and Coliseum premises, the segregated garbage will be **recorded, weighed and stored at the Capitol's Materials Recovery Facility (MRF)** for proper disposal.

The Offices outside the Capitol, the **segregated garbage will be recorded and weighed (estimates only) for submission to PENRO-LGU**. The segregated garbage will be collected by the City Environment and Natural Resources Office (City ENRO) for proper disposal.

## **CLASSIFICATION OF SOLID WASTES**

### **a. BIODEGRADABLE WASTE (MALATA)**

- FRUIT AND VEGETABLE PEELINGS, LEFTOVER FOODS,
- DRIED LEAVES AND GRASSES, SEEDS/LEAVES/FLOWERS,
- AGRICULTURAL WASTE- SAWDUST, COCO-COIR DUST, RICE STRAW, CORN COBS, BANANA STALKS, ETC.

### **b. RECYCLABLE WASTE (MAPUSLAN)**

- PAPER/CARTONS (USED BUT CLEAN AND DRY)
- PLASTICS- PET BOTTLES, POLYETHYLENE (PE) AND HIGH DENSITY POLYETHYLENE (HDPE) BAGS/CONTAINERS
- METALS- STEEL, COPPER, ALUMINUM, IRON, ETC.
- GLASS- BOTTLES, EMPTY VIALS

### **c. RESIDUAL WASTE (DILI NA MAPUSLAN)**

- SANITARY NAPKINS, DISPOSABLE DIAPERS, WORN-OUT RUGS, USED TOILET PAPER, FACE MASKS, FACE SHIELDS\*, USED TISSUE PAPER
- CARTONS WHICH CONTAIN PLASTIC LINING, USUALLY USED FOR MILK AND JUICE CONTAINERS
- CANDY WRAPPERS, SACHETS, SANDO BAGS AND POLYSTYRENE (STYROFOAM/STYROFOR)
- TATTERED TEXTILE AND PACKAGING MATERIALS
- SOILED/WET PAPER AND BOX/CARTON
- OTHER SOILD MATERIALS THAT CANNOT BE COMPOSTED AND RECYCLED
- BROKEN GLASS AND CERAMICS

### **d. SPECIAL WASTE (DELIKADO/MAKAHILO)**

- SPRAY CANISTERS (AIR FRESHENERS AND DISINFECTANT SPRAYS)
- BATTERIES, WORN-OUT CELLPHONES, LAPTOPS AND OTHER ELECTRONIC WASTE (E-WASTE)
- BUSTED FLOURESCENT TUBES, COMPACT FLOURESCENT LAMPS (CFLs) AND BULBS
- POLY VINYL CHLORIDE (PVC) TILES, PIPES, EMPTY PAINT CONTAINERS/THINNERS AND TIRES
