WEEKLY ACCOMPLISHMENT REPORT

(Period Covered: November 22-28, 2021)

Campaign Against Illegal Drugs

Buy-Bust Operations:

On November 23, 2021 at about 6:02 PM, Personnel from City Drug Enforcement Unit (CDEU) and Intelligence Unit of Digos City Police Station led by **PLT JOSELITO A CORTES**, CDEU/Intel Officer together with the personnel from RSOG 11 led by **PLTCOL RONALD LIM LAO**; PDEU, PIU and PDEA Davao del Sur under the overall supervision of **PLTCOL HAMLET M LERIOS**, OIC, covered with PDEA RO XI Pre Operation Number 30004-112021-0358 conducted joint Anti-illegal Drug "Buy-bust" Operation at Purok Anahaw, Brgy San Miguel, Digos City that resulted in the arrest of **ALBERTO OLIVO COLE alias Dong**, 24 years old, male, with live-in partner, waiter and a resident of Purok Gemelina, Odaca, Brgy. San Miguel, Digos City. Subject person is classified as Regional Target Top 9 categorized as High Value Individual.

Pieces of evidence recovered from the possession and control of the suspect, including the buy-bust item, are listed below:

- a. One (1) pc. heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (Buy-Bust Item);
- b. Three (3) pcs heat-sealed transparent plastic sachet containing white crystalline substance believed to be shabu (possession items);
- c. One (1) piece genuine One Thousand Peso bill (P1,000.00) used as marked money bearing serial number BH320392 with initial markings "JAN";
- d. One (1) unit Vivo Y11 brand android cellular phone color black;
- e. One (1) pc. disposable lighter color blue;
- f. One (1) pc. coin purse color green; and
- g. One (1) unit Wave 100 motorcycle color red/black with attached plate number 4772 QK with ignition key.

The arrested suspect as well as the pieces of evidence listed above were immediately brought to Digos CPS for recording and for proper disposition.

The arrested suspect will be brought to Davao del Sur Provincial Hospital (DSPH) for medical Examination. The seized drug evidence together with the arrested suspect will be brought to Davao Sur Provincial Crime Laboratory (DSPCLO) located at Magsaysay St., Digos City for laboratory and drug test examination.

Buy-bust and Possession drug items have an estimated weight of MOL 0.18 grams of suspected methamphetamine hydrochloride or "shabu" with estimated DDB value of One Thousand Two Hundred Twenty-four Pesos (Php 1,224.00).



On November 24, 2021 at about 5:10 PM, PNP personnel from Sta. Cruz MPS led by PMAJ CRISALDO R GAILA-COP together with personnel from PDEA XI Davao Sur led by Agent Mildred Driz; personnel from PDEU led by PMAJ EDILBERO P CABILLO; personnel from PIU led by PLTCOL RAMIL MACARAMPAT; personnel from 1st DSPMFC led by PLT JANREYWAN ABADIA; and personnel from RMFB11 1104TH MC led by PCPT RICHARD P LAPACEROS conducted joint anti-illegal drug buy-bust operation under PDEA Pre-ops number 30004-112021-0389 time 1220H at Purok Parrot, Brgy. Inawayan, Sta Cruz, Davao del Sur which resulted in the arrest of **Edwin Heralla Biñas**, @ Heti-heti / Weti-weti, male, 43 years old, single, jobless and a resident of Purok Parrot, Brgy. Inawayan, Sta. Cruz, Davao del Sur (listed as High Value Individual no. 5).

Recovered from possession and control of Edwin Heralla Biñas during the buy bust operation were the following:

- a. one (1) piece heat sealed transparent plastic sachet containing crystalline substance believed to be shabu (buy-bust item);
- b. Eleven (11) pieces heat sealed transparent plastic sachet containing crystalline substance believed to be shabu (subject for possession);
- c. One (1) piece One Thousand Peso Bill (Php. 1,000.00) bearing serial number RK263728 with initial "APLR" (marked money);
- d. Cash money amounting to Two Thousand One Hundred Pesos (Php 2,100.00) in different denomination;
- e. One (1) unit digital weighing scale;
- f. One piece pouch color gray.;
- g. one coin purse, stripe;
- h. One unit cellular phone/my phone, analog color black;
- i. One ballcap color black with nike logo;
- j. wo (2) pieces small paper color white; and
- k. Three (3) pieces improvised paper container.

Tagging, marking and inventory of all recovered pieces of evidence were immediately conducted at the crime scene in the presence of Brgy. Captain Danilo A Baquial of Brgy. Inawayan, Sta Cruz, Davao del Sur, Ramon P Susano Jr- Media Representative and Rolando D Patos from DOJ. The recovered drug item has an

estimated weight of more or less 0.44 gram with an estimated DDB value of Two Thousand Nine Hundred Ninety-two Pesos (Php 2,992.00).

The arrested suspect is now temporarily held at Sta Cruz MPS for proper disposition while the recovered drug items will be turned-over to Provincial Crime Laboratory Office, Digos City for laboratory examination. Likewise, the arrested suspect was brought to PCLO for Urine Test Examination.



Campaign Against Illegal Gambling

On November 22, 2021 at about 6:50 PM, personnel from Bansalan MPS led by **PLT ORLANDO C UDALVE-OIC**, together with PSSG Oliver Ace Nerona, PCPL Francis Kieth Dumayas, PSMS Jeric Canete and PSSG EdwinYeso, successfully arrested the persons of one **MARIO LAVISTO NAVASCA**, male, 65 years old, married a resident of Del Pilar St, Poblacion Dos, Bansalan, Davao del Sur, (two) **CANDILARIA EMBAJADOR ESPELLITA**, female, 53 years old married a resident of Purok Panaghuisa, Brgy Tubod, Bansalan, Davao del Sur, (three) **ERNESTO CAGAS SUPILANAS**, male, 37 years old, single, a resident of Purok Panaghuisa, Brgy Tubod, Bansalan, Davao del Sur, they were caught in the act playing cards locally known as tong-it at the open shanty outside the house of Mr. Navasca located at the same place. Said arrested persons were properly apprised of their constitutional rights in the dialect known and understood by them.

Confiscated from their possession and control are the following items to wit:

- a. One (1) set playing cards;
- b. Two (2) pieces 100 – peso bill;
- c. Two (2) pieces 50 – peso bill;
- d. Three (3) pieces 20– peso bill;
- e. One (1) piece 10 – peso coin;
- f. Three (3) pieces 5 – peso coin; and
- g. Five (5) pieces 1 – peso coin;

Subject arrested persons and the confiscated items are now in the custody of Bansalan MPS and preparing a case for Violation of Presidential Decree 1602.

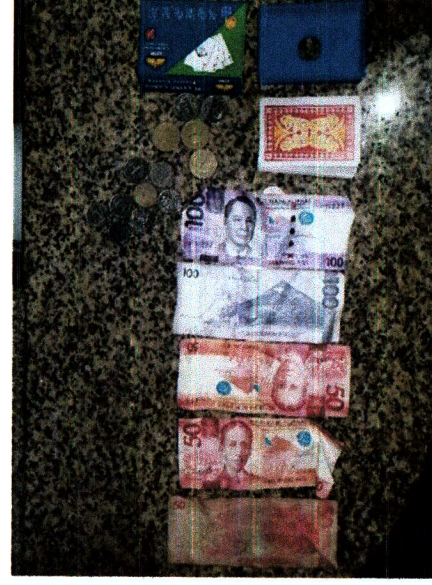


On November 23, 2021 at about 9:30 PM, A concerned citizen called Magsaysay MPS through cell phone informing that there was on going illegal gambling activities particularly playing cards locally known as Tong-its at Purok 5, Brgy Barayong, Magsaysay, Davao del Sur.

Immediately, Intel operatives of Magsaysay MPS led by PSMS Rhanil V Jusay under the supervision of **PCPT HAROLD S UNTALAN**, and 1104th RMFB 11 operatives led by Pat Dexter N Dalumatan under the supervision of **PCPT RICHARD P LAPACEROS**, were dispatched and proceeded to the said place that resulted in the arrest of the following persons namely; **QUINN TUBALADO**, male, 24 years old, single, Cebuano, laborer and a resident of Brgy Site, Purok 1, Brgy Kasuga, Magsaysay, Davao del Sur; **VIRGINIA BORDIOS FERNANDEZ**, 56 years old, female married, housewife, married and resident of Purok 5, Brgy Barayong, Magsaysay, Davao del Sur, and **MELISSA BARIOG NAVALEZ**, 37 years old, female, married, housewife and a resident Purok 5, Brgy Barayong, Magsaysay, Davao del Sur who were caught in the act playing cards illegally locally known as (**TONG-ITS**) at about 10:00 PM of this date in the kiosk of Navalez family.

Confiscated from their possession and control are the ff: one (1) set of red playing cards; Two (2) pieces One Hundred Peso bills (Php 100.00); three (3) pieces Fifty Peso bills (Php 50.00); five (5) pieces of Five Peso coins (Php 5.00); and eight pieces of one (1) peso coins all in all amounting to Three Hundred Eighty-three pesos (Php 383.00) as their bet money.

The respondents and evidence are now under custody of said station for proper disposition.

Langa-an, Matanao, Davao del Sur (2) Ryan Capa, 26y.o, single, unemployed and a resident of Prk. 3, Brgy. Lower Marber, Matanao, Davao del Sur (3) Jirommy Villafuerte Subido, 21 y.o, unemployed and a resident of Prk. 7, Brgy. Langa-an, Matanao, Davao del Sur (4) Jomar Margaha, 32y.o, married, laborer and a resident of Prk. 7, Brgy. Langa-an, Matanao, Davao del Sur (5) Jay-ar Ordaneza Bustamante, 18 y.o, single, student and a resident of Prk. 2, Brgy. Langa-an, Matanao, Davao del Sur;

Above-named suspects were caught in the act by the operating PNP personnel engaged in illegal gambling activity, “playing volleyball” with bet money. Recovered evidences at the place of incident were the following: One (1) pc Volleyball net; one (1) pc score board and bet money amounting to One Thousand Four Hundred (1,400) pesos in different denominations, to wit; Twelve (12) pcs One Hundred Peso Bill; and Four (4) pcs Fifty Peso Bill;

Arrested persons and the recovered items are now under the custody of Matanao MPS and Violation of PD 1602 will be charged against the subject persons.



On November 11:56 AM of November 27, 2021, An anti-illegal gambling operation was conducted by Intel/CDEU personnel of Digos CPS led by PSSG Eimer Mariscal under the supervision and control of **PLTCOL HAMLET M. LERIOS, OIC**, that resulted to the arrest of the following persons to wit; **1.) WILFREDO TILUD LUMEN, M, 20y/o, un-employed, a res of Chapter 4, Brgy.Aplaya, Digos City 2. 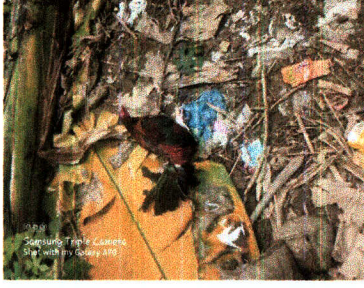
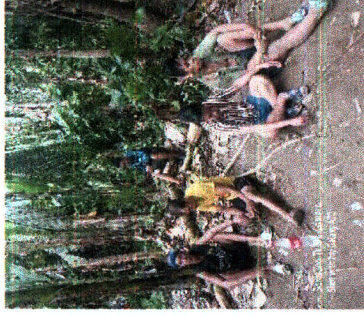
Recovered from their possession and control were the following:

- e. One (1) yellow small box with gambling paraphernalias



The arrested suspects were informed the nature of their offense they committed and their constitutional rights and placed under police custody of Digos CPS while preparing documents for inquest proceeding.

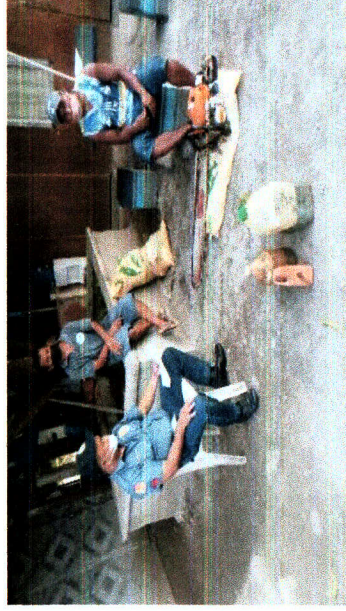
Other Operational Accomplishments

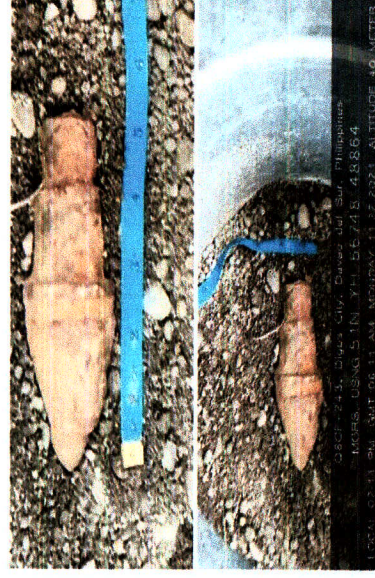
Spot Report on Recovered UXO

Darong, Sta Cruz, Davao del Sur turn over an alleged UXO that was accidentally found upon digging at the place where he was working at BMEG CORP. Oro Cement Compound, Purok Papaya, Sitio Landing, Brgy. Darong, Sta Cruz, Davao del Sur. PECU Davao del Sur personnel composed of PMSG Rogelio V Niño Jr (OS), PSSg Mark Jefferson J Ersando, PCpl Joseph E Tabano and PCpl Roberto Jr T Salmorin (OS) , all under the supervision of **PCMS Kirk R Sabillo**, TL ,were dispatched on board to Toyota HILUX with Plate Nr. POA 580 driven by

PSSg Rocky N Nerosa, Duty Driver of DSPPO and proceeded to 2nd Platoon, MFC, 1st DSPMFC to verify the alleged UXO found.

At around 1:20 PM of the same date, PECU Davao Sur personnel arrived at 2nd Platoon MFC, 1st DSPMFC, Brgy. Darong, Sta Cruz, Davao del Sur, Upon arrival Team immediately coordinated with **PLT JAN REYWAN L ABADIA**, Platoon Leader of 2nd Platoon MFC, 1st DSPMFC to verify the turn-over alleged UXO. Upon assessment of the EOD Technician it was identified as One (1) Fuze, 105 mm, corroded.

Activity ended at around 1:40 PM of the same date with no untoward incident happened.



Accomplishment Report on Apprehension of Suspect on Hacking Incident

On November 22, 2021 at 7:30 PM, Sta Cruz MPS received a cellular phone call from a concerned citizen that there was a hacking incident transpired at Sitio Sibulan, Brgy. Astorga, Sta. Cruz Davao del Sur. PNP personnel of Sta Cruz MPS led by PEMS Joepet Maetem proceeded to the reported place to verify the report and conduct investigation thereafter.

Initial investigation conducted disclosed that victim was identified as Junryl Colita Toledo, 30 yrs old, married, farmer and a resident of Sibulan Beach, Brgy. Astorga, Sta. Cruz Davao del Sur while suspect was identified as Ranel Payan Moda, 29 years old, live-in status, farmer and a resident of Sitio Sibulan, Brgy. Astorga, Sta. Cruz, Davao del Sur. Further investigation conducted revealed that victim and suspect had a drinking spree and without any apparent reason suspect got a bolo (lagaraw) and hacked the victim. Victim was brought at Davao Sur Provincial Hospital for medical treatment while the suspect was successfully arrested by responding PNP personnel.

Accomplishment Report on Apprehension of Suspect re Motor napping Incident

Accomplishment Report on Apprehension of Person for Direct Assault and Alarm and Scandal

At about 4:50 PM of November 26, 2021, Sta Cruz MPS received a cellphone call from Brgy. Kagawad Rogilio Ading Ramillano of Brgy. Zone 2 Sitio Lubo, Sta. Cruz, Davao del Sur that suspect identified as **Garold Flores Fuellas**, 42 yrs old, married, jobless and a resident of Sitio Lubo, Brgy. Zone 2, Sta Cruz Davao del Sur went wild at his residence. PNP personnel of Sta Cruz MPS led by PSSg Mark Gregore Okit proceeded to to the reported place to verify the report.

Initial Investigation conducted disclosed that at about 4:20 PM of same date, suspect together with alias Niño had a drinking spree at the house of the suspect. Moments later, suspect went wild which prompted his mother identified as Melagros Flores Fuellas to ask help to her neighbor in the person of Brgy . Kagawad Vergilio Diego Colon. Then and there, Brgy. Kagawad Colon tried to pacify the suspect but failed and asked the assistance to Brgy. Kagawad Rogilio Ading Ramillano.

When Brgy Kagawad Ramillano pacified and advised the suspect to be calm and get some rest, suddenly suspect approached and insulted him uttered in vernacular word to quote **"AYAW PAG APIL-APIL KAY WALA KAY LABOT, WALA KA KABALO SA PROBLEMA NAKO SA AKONG PAMILYA, GAMITA IMONG OTOK BA"**. When suspect touched and pointed the head of Kag. Ramillano, thereafter Kag. Ramillano tapped the hand of the suspect. Suspect punched Brgy Kagawad Ramillano hitting his right portion of the neck. The responding PNP personnel of Sta. Cruz MPS successfully arrested the suspect and he is now under the custody of Sta Cruz MPS for proper disposition.

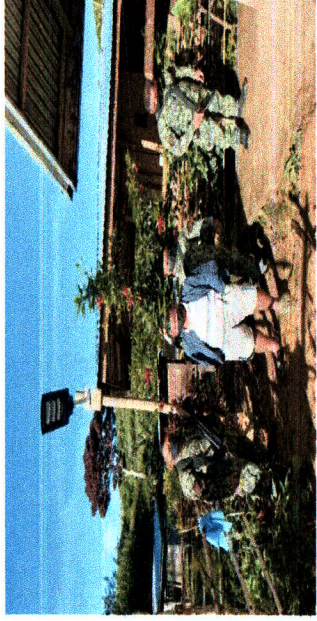


Installation of Solar light Panel as an Additional Perimeter Light
